FAQs

Q. What is the deadline for making a Payroll Deduction gift?

A. You can sign up at any time of the year.

Q. When does the Payroll Deduction for this campaign begin and end?

A. Payroll deduction for your gifts will begin on the next pay period after your pledge form is processed. Your gifts will continue until you let the Foundation know that you would like to stop your payroll deduction.

Q. How do I make a gift to the Riverview Heart @ Work campaign?

A. Payroll deduction provides the easiest way to contribute to the Riverview Heart @ Work Campaign. You may also make a one-time gift with a check or credit card.

Q. Where does my gift go?

A. You decide where you want to direct your support. You can direct your gift to the area of greatest need. Or you can direct your gift to a specific unit or fund within Riverview Health Centre.

Q. Can I divide my gift between more than one designated fund?

A. Yes! For example, if you choose to give \$10 per pay, you can split your gift so \$5 goes to the area of greatest need and \$5 goes to the technology fund (or whichever funds/ units mean the most to you).

Q. How much should I give?

A. You can choose any amount you would like to donate (however, minimum payroll deduction is \$2 per pay).

Q. Is my gift tax deductible?

A. Yes! The total amount of your charitable donation through payroll deduction will appear on your T4 and can be claimed on your income tax. There are no extra tax receipts to keep track of!

Q. Can I sign up for payroll deduction if I am working part-time or casually?

A. Yes! Your donation will only be made through payroll deduction whenever

A. Yes! Your donation will only be made through payroll deduction whenever you receive a pay check.

Q. Does giving \$5 a pay really make a difference?

A. Absolutely! \$5 per pay works out to about \$0.33 a day which does not sound like it could make a huge difference, but it does! \$5 a pay is \$120 annually and if even 50% of RHC staff gave \$5 per pay, the total impact would be \$45,000 annually!

Q. What is Riverview Health Centre Foundation?

A. The Riverview Health Centre Foundation is a non-profit, charitable organization that provides funds to the Riverview Health Centre to support its vision, goals and operation. Q. How will my donation be used?

Q. Will anyone know that I donate or how much I donate?

A. No. All donor information is confidential. From time to time we do ask for staff who give if they would like to share publicly why they choose to give. But this is your choice. We would never share your giving story without your permission.

Q. What if I want to cancel my payroll deduction or increase the amount of my payroll deduction?
